Pursuant to Section 98.075(7) of the Florida Statutes, the following persons are hereby notified that they are potentially ineligible to be registered to vote. Failure to respond within thirty (30) days of this notice may result in determination of ineligibility by the Supervisor of Elections and removal of the registered voter’s name from the statewide voter registration system.

For information regarding the basis for the potential ineligibility, and the procedure to resolve the matter, contact the Supervisor of Elections at 561-656-6200 no later than thirty (30) days after the published date of this notice.

If the voter denies the accuracy of the information underlying the potential ineligibility, the voter has a right to request a hearing for the purpose of determining eligibility.

If you attempt to vote at an early voting site or your normal election day polling place, you will be required to vote a provisional ballot. If you vote by mail, your ballot will be treated as a provisional ballot. In either case, your ballot may not be counted until a final determination of eligibility is made. If you wish for your ballot to be counted, you must contact the supervisor of elections office within 2 days after the election and present evidence that you are eligible to vote.
